Who is Easternwell?

What are Easternwell Community Grants?

The Easternwell Community Grants (ECG) program was established in 2011 to provide financial and social assistance to the communities where we conduct business.

Easternwell is seeking funding partnerships which provide lasting benefits with grants to be allocated to community groups, clubs, associations and committees.

What are our priority areas for funding?

Easternwell aims to support activities or opportunities which provide lasting community benefit in the areas of:

- Community
- Education and Training
- Health
- Indigenous
- Safety
- Youth

Examples of projects which will be looked upon favourably include:

- Purchasing equipment
- Contributing to building or infrastructure
- Development of training programs

What is the funding application criteria?

There are certain exclusion from the ECG where applications will not be considered:

- Individual submissions including those seeking support for activities such as academic studies, travel or fundraising for other organisations
- Requests relating to political organisations or campaigns
- Support for religious organisations for religious benefit
- Third party applications ie. one organisation applying for funds to benefit the project of another
- Retrospective activities
- Projects which are run primarily for commercial purposes or events designed primarily for the purpose of fundraising

Projects which will be positively considered for grant funding will:

- Demonstrate long lasting benefits to the community
- Enhance community operations through programs, infrastructure or equipment
- Enhance the capability of the organisation
- Be located within key areas in close proximity of Easternwell operations

Projects which request funding for the following costs, will not be considered for funding:

- Administrative costs or overheads of the applicant
- Costs that subsidise the routine operations of the applicant
- Working capital, debt finance or service financing arrangements
- Overseas travel costs

How much can I apply for?

Easternwell Community Grants will provide funding assistance up to \$2,000 per applicant per round.

How do I apply?

All ECG applications must be submitted by email or post. These will be evaluated by the ECG Committee.

Application Assessment

ECG applications are assessed bi-annually in March and September. Applications must be received by the ECG Committee before or on the closing date:

Friday 23 September 2011

Friday 23 March 2012

A selection panel will review all submissions and applicants will receive a response within 4-6 weeks of closing date.

Process:

- ECG Committee assesses all applications 2-3 weeks after the closing date.
- Applicants informed of result of application within 2-3 weeks of committee review.
- Payment process may take up to 8 weeks from approval date.
